Joint Commission announces accreditation of DaVita Inpatient Dialysis Units

For the first time, The Joint Commission has awarded Ambulatory Health Care Accreditation to an inpatient kidney care provider, DaVita Hospital ServicesSM. Denver-based DaVita[®], with nearly 700 sites located in Joint Commission-accredited hospitals across the U.S., is a division of DaVita HealthCare Partners Inc. This achievement involved two and a half months of surveys at more than 175 DaVita inpatient dialysis sites. Accreditation can assist the hospital partners in risk management and reduction. and survey preparedness. It also complements a hospital's Joint Commission hospital accreditation and does not replace or diminish a hospital's current or future accreditation. DaVita, its hospital partners and other entities have committed to using The Joint Commission's ambulatory standards as a framework to systematically monitor and evaluate the quality and safety of kidney care therapies. Continuous compliance with accreditation standards is designed to improve the quality and safety of the inpatient dialysis environment in a hospital setting. Certification

In development: Behavioral Health Home Certification

The Joint Commission is developing a new Behavioral Health Home Certification product to recognize organizations that have successfully integrated primary physical and behavioral health care. The optional certification will go above and beyond what is required for accreditation and provide additional recognition. If approved, The Joint Commission will begin offering this new certification option for organizations accredited under its Behavioral Health Care Accreditation program beginning January 1, 2014. Work is underway to develop the standards and on-site survey process. Input has been gathered from experts on the various models of behavioral health homes and from organizations accredited under The Joint Commission's behavioral health care accreditation program and that are in the early stages of offering these services. A field review to solicit feedback on the proposed standards is now taking place. Once approved, the prepublication standards will be posted on the website in summer 2013, with final publication in fall 2013 in the *Comprehensive Accreditation Manual for Behavioral Health Care*.

The Affordable Care Act has enabled many states to establish behavioral health homes. Behavioral health homes integrate physical health care services with behavioral health care which can improve the quality of life for individuals by providing preventive care and coordinated treatment that addresses the needs of the whole person. Behavioral health home providers do not need to provide all the services themselves, but must ensure that the full array of primary and behavioral health care services is available and coordinated.
